REGARDING EMPLOYEES AVAILABLE FOR
HIRE AS POLICE OFFICERS.

Whereas, the Council of the Village of Elida, Ohio met at a duly called and authorized meeting of the Council, such meeting being duly called pursuant to the rules of Council, with notice received by all Council members.

Whereas, it is desirable for the Village of Elida, Ohio to allow additional hiring of police officers and personal, as deemed appropriate, budgetarily approved, and in the best interest of the peace and welfare of the Village.

Whereas, amendments to said code shall be as follows:

1. Village of Elida, Ohio shall be permitted to have as many as seven (7) part-time or complimentary officers available to said Village in hours and services that are commensurate with the budget of the Village and approved by the Mayor.
2. A detective position shall be established, but is not required to be filled. Such position shall have a pay range of \$20.00 to \$25.00 per hour and hours shall be commensurate based on the Chief of Police direction
3. A Law Enforcement Data Systems (L.E.A.D.S.) Tactical Officer position with a pay range of \$20.00 to \$25.00 per hour and hours shall be commensurate based on the Chief of Police direction
4. It is not required the Chief of Police fill all positions, and all positions shall be managed within the budget allocated for the police.

Whereas, it is desirable for other terms under said ordinance specifically modified herein, shall remain in full force and effect.

Whereas, the Council of the Village of Elida, by an affirmative vote of the majority of the members elected, approved Ordinance # 1178-2021 read by title on three different days as proscribed by law.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELIDA, OHIO, BY A MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING:

Section 1. That the Ordinance 1173-2020 is hereby amended to allow the hiring of up to seven (7) part time police officers.

Section 2. A detective position and a Law Enforcement Data Systems (L.E.A.D.S.) Tactical Officer position shall be made available to the Chief of Police at pay ranges of \$20.00 to \$25.00 per hour and hours as directed by the Chief of Police, in connection and conformity of the police budget.

Section 2. That all other provisions outlined in 1173-2020 shall remain in full force and effect.


Section 3. That the Council of the Village of Elida, Ohio authorizes the Fiscal Officer to make publication and approval from the earliest period prescribed by law.
