

ORDINANCE NO. 1190 - 2021

AN ORDINANCE: MAKING TEMPORARY AND PRELIMINARY APPROPRIATIONS FOR THE CURRENT AND ORDINARY EXPENSES OF THE VILLAGE OF ELIDA, OHIO, FOR THE PERIOD BEGINNING JANUARY 2022, AND UNTIL THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF ELIDA, OHIO, IS IN FULL FORCE.

Whereas, the Council of the Village of Elida, Ohio met at a duly called and authorized meeting of the Council, such meeting being duly called pursuant to the rules of council, with notice received by all council members; and

Whereas, Ohio Revised Code Section 5705.38 provides that after the beginning of the fiscal year and before the annual appropriations ordinance had been passed, the council may make appropriations for the ordinary expenses of the Village until the annual appropriations ordinance is in force; and

Whereas, a need exists in the usual daily operation of the Village government in that in order to provide for the current and ordinary expenses of the Village, it is necessary to make temporary and preliminary appropriations until the adoption of the 2022 appropriations ordinance and by reason thereof.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELIDA, OHIO, TWO-THIRDS OF THE ELECTED MEMBERS ELECTED THERETO CONCURRING:

Section 1. That it is provided that the 2022 appropriation figures shall be continued and adopted temporarily for the current and ordinary expenses of the Village of Elida, Ohio, for the period beginning January 1, 2022, and until the annual appropriations ordinance is in force, and is no event longer than April 1, 2022.

Section 2. That the full authority of the Council is hereby given for the proper officials to expend the appropriations necessary to provide for the current and ordinary expenses of the Village of Elida, Ohio, until the annual appropriations ordinance is in force and in no event longer than April 1, 2022.


Section 3. That the Village Fiscal Officer is authorized and directed to draw her warrants against the proper appropriation items in payment of the obligations herein authorized upon presentation of the proper voucher or vouchers.

Section 4. That the Council of the Village of Elida, Ohio hereby finds that all discussion and debate regarding the matter was conducted in open session of council pursuant to the provisions of the Ohio Revised Code.

Section 5. That the Village Fiscal Officer be and hereby is authorized and directed to cause publication of this Ordinance to be made in a manner as provided for according to law.

Section 6. That for the reasons set forth in the preamble, this Ordinance after approval by the Mayor shall take effect and be in full force from and after the earliest period allowed by law, provided that it receives the affirmative vote of two-thirds of the members elected to the Council.


