AN ORDINANCE: OF THE VILLAGE OF ELIDA,  
OHIO AUTHORIZING THE FEE SCHEDULE  
FOR LAWN MOWING AND CARE AND  
DECLARING AN EMERGNECY

**Whereas**, the Council of the Village of Elida,  
Ohio met at a duly called and  
authorized meeting of the Council, such meeting  
being duly called pursuant to the rules of  
Council, with notice received by all Council  
members.

**Whereas**, it is desirable for the Village of Elida,  
Ohio to address properties that are unsightly and not properly mowed, and that the  
reimbursement rate for said time is not sufficient to cover the costs.

**Whereas**, the Council of the Village of Elida, by an affirmative vote of three fifths of the  
members elected, approved Ordinance # 1239-2025.

**WHEREAS**, an emergency now exists to protect the safety, health, and/or welfare of  
the public and that the rules be suspended.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF  
ELIDA, OHIO, BY A MAJORITY OF THE MEMBERS ELECTED THERETO  
CONCURRING:**


**Section 1.** That the reimbursement rate assessed on any property mowed by the  
Village of Elida, Ohio due to not properly caring for said property shall be billed and  
assessed as follows: standard hourly rate for mowing and operator and any  
administrator fee as appropriate based on time and material. Upon the third time  
mowing of the same property in the calendar year, that cost shall be assessed in the  
same way, and thereafter upon said mowing shall double due to strain and stress  
placed on equipment and staff of the Village.

**Section 2.** That the Council of the Village of Elida, Ohio hereby finds that all discussion  
and debate regarding the matter was conducted in open session of council pursuant  
to the provisions of the Ohio Revised Code.

**Section 3.** That the Council of the Village of Elida, Ohio authorizes the Fiscal Officer to make publication and approval from the earliest period prescribed by law.

**Section 4.** That the Council of the Village of Elida, Ohio under suspension of the rules, declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, safety, welfare and morals, such emergency arising out of necessity for the administration of the Village of Elida, Ohio without due delay: wherefore this Resolution shall take effect and be in full force from and after its passage and approval by the Mayor.


