

RESOLUTION NO. 537 - 2025

A RESOLUTION: OF THE VILLAGE OF ELDIA OHIO ACCEPTING THE BID OF RUMPKE WASTE & RECYCLING SERVICES FOR WASTE & RECYCLING SERVICES IN THE VILLAGE AND PERMITTING THE ADMINISTRATOR AND/OR MAYOR TO ENTER INTO CONTRACT WITH RUMPKE AND DECLARING AN EMERGENCY

WHEREAS, the Village of Elida, Ohio met at a duly called and authorized meeting of the Council, such meeting being duly called pursuant to the rules of Council, with notice received by all Council Members, and

WHEREAS, the Village of Elida is desirous and need to enter into contract for waste and refuse pick-up services in the Village.

WHEREAS, the Village of Elida entertained bids for said services, and found Rumpke Waste & Recycling Services to be the lowest and best bid.

WHEREAS, it is necessary for the Village of Elida, Ohio to set a rate for completion of these services from Village residents.

NOW, THEREFORE, BE IT ORDAINED BY A MINIMUM OF THREE-FOURTH'S VOTING by the Council of the Village of Elida, Ohio:

Section 1. That this Council does hereby authorize the Administrator of the Village of Elida, and/or Mayor to enter into contract with Rumpke Waste & Recycling Services for the purposes of serving the Village of Elida, Ohio in said regard for waste and refuse pickup. Said contract shall not exceed five (5) years.

Section 2. That this Council deems it necessary to charge a reasonable and necessary fee of the Village of Elida residents for said services, being a rate of twenty-eight dollars and 25/100 (\$28.25) per month for each unit utilizing the services of Rumpke. Said rate shall remain until the end of the contract, or until further resolution of this Council.

Section 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety, and welfare in the County and for the usual daily operation of the Village of Elida for the reasons set forth and defined in the preamble to this Resolution, and provided it receives the affirmative vote of at least three fourths the members of this Council, this Resolution shall take effect and be in force immediately upon its adoption by this Council or otherwise it shall take effect and be in force after the earliest period allowed by law.

Section 4. That this shall become effective at the earliest prescribed period permitted per law. The clerk shall publish as deemed appropriate.
