**Whereas**, it is desirous of the council of the Village of Elida to allow said village of Cooperative Purchase Program.

**Whereas**, an emergency exists in that for the preservations of the public safety, Elida, Ohio and stated herein, and therefore this Resolution shall take effect forthwith:

**Whereas**, the Council of the Village of Elida, by an affirmative vote of three-fourths of the members elected, approved Resolution # 540-2025 read by title, and moved that the rule requiring Resolutions to be read by title on three different days be suspended pursuant to section 731.17 of the Revised Code of Ohio.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELIDA, OHIO, THREE-FOURTHS OF THE MEMBERS ELECTED THERETO CONCURRING:**

**Section 1.** That it is hereby declared to be in the public interest that Elida, Ohio be permitted to participate in cooperative purchasing program regarding the State of Ohio Cooperative Purchasing Program, and allowing the Administrator and/or Mayor to enter into any agreement regarding the same.


**Section 2.** The Village of Elida, Ohio, hereby permits said agreement finding it to be in the best interest of the citizens of the village and public at large.

**Section 3.** The Village Fiscal Officer for the Village of Elida, Ohio is authorized and directed to cause publication of this Resolution to be made in a manner as provided for according to law.

**Section 4.** That the Council of the Village of Elida, Ohio hereby finds that all discussion and debate regarding the matter was conducted in open session of council pursuant to the provisions of the Ohio Revised Code.

**Section 5.** That the Council of the Village of Elida, Ohio under suspension of the rules, declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, safety, welfare and morals, such emergency arising out of necessity for the administration of the Village of Elida, Ohio without due delay: wherefore this Resolution shall take effect and be in full force from and after its passage and approval by the Mayor.
