Whereas, it is necessary for the health, safety, and welfare of the Village of Elida, Ohio to amend a contract with Rumpke of Ohio, Inc. for refuge pickup.

Whereas, an emergency exists in that for the preservations of the public safety, it is immediately necessary to authorize the improvements of said streets in the Village of Elida, Ohio and stated herein, and therefore this Ordinance shall take effect forthwith:

Whereas, the Council of the Village of Elida, by an affirmative vote of three-fourths of the members elected, approved Ordinance # 1240-2025 read by title, and moved that the rule requiring Ordinance to be read by title on three different days be suspended pursuant to section 731.17 of the Revised Code of Ohio.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELIDA, OHIO, THREE-FOURTHS OF THE MEMBERS ELECTED THERETO CONCURRING:

Section 1. That it is hereby declared to be in the public interest that the consent of Council of the Village of Elida, Ohio be, and hereby agreeable that the Village has adjusted refuge rates to a price for the monthly basis of \$29.00 per unit monthly price starting June 13, 2025.

Section 2. The Village Fiscal Officer for the Village of Elida, Ohio is authorized and directed to cause publication of this Resolution to be made in a manner as provided for according to law.

Section 3. That the Council of the Village of Elida, Ohio hereby finds that all discussion and debate regarding the matter was conducted in open session of council pursuant to the provisions of the Ohio Revised Code.

Section 4. That the Council of the Village of Elida, Ohio under suspension of the rules, declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, safety, welfare and morals, such emergency arising out of necessity for the administration of the Village of Elida, Ohio without due delay: wherefore this Resolution shall take effect and be in full force from and after its passage and approval by the Mayor.
