

ORDINANCE NO. 1245 - 2025

**AN ORDINANCE APPROVING THE  
EMPLOYMENT OF BARRY SCHROEDER AS  
VILLAGE SOLICITOR FOR A ONE YEAR  
PERIOD PURSUANT TO ORC 733.48  
BEGINNING JANUARY 1, 2026 THROUGH  
DECEMBER 31, 2026.**

**Whereas**, the Council of the Village of Elida, Ohio met at a duly called and authorized meeting of the Council on the date set forth below, such meeting being duly called pursuant to the rules of council, with notice received by all council members; and

**Whereas**, to preserve the usual daily operations necessary to the citizens and the Village government of the Village of Elida, Ohio, in that the Ordinance approving the employment and setting the pay rates to be paid to the Village Solicitor Barry Schroeder expires on December 31, 2026 and that in order to continue his services to the Village of Elida, for a one-year period pursuant to ORC 733.48.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELIDA, OHIO, TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING:**

**Section 1.** That the Council of the Village of Elida, Ohio hereby employs Barry Schroeder as Village Solicitor, to provide legal services without interruption to the Village of Elida, Ohio, for a one-year period pursuant to ORC 733.48, beginning January 1, 2025 through December 31, 2026.

**Section 2.** That Village Solicitor, Barry Schroeder will receive compensation in the amount of \$1,500.00 per month.


**Section 3.** The Village Fiscal Officer for the Village of Elida, Ohio is authorized and directed to cause publication of this Ordinance to be made in a manner as provided for according to law.

**Section 4.** That the Council of the Village of Elida, Ohio hereby finds that all discussion and debate regarding the matter was conducted in open session of council pursuant to the provisions of the Ohio Revised Code.
