

RESOLUTION NO 543 - 2025

**A RESOLUTION OF THE VILLAGE OF ELIDA, OHIO AUTHORIZING THE MAYOR AND/OR THE VILLAGE ADMINISTRATOR TO DISPOSE OF UNNEEDED, OBSOLETE OR UNFIT PERSONAL PROPERTY BY INTERNET AUCTION DURING THE CALENDAR YEAR 2026 AND REQUIRING PUBLICATION OF THE SAME, AND AUTHORIZING THE MAYOR AND/OR VILLAGE ADMINISTRATOR TO EXECUTE ON BEHALF OF THE VILLAGE A CONTRACT WITH GOVDEALS.COM.**

**Whereas**, The Council of the Village of Elida, Ohio met at a duly called and authorized meeting of the Council, such meeting being duly called pursuant to the rules of Council, with notice received by all Council members; and

**Whereas**, the Village is empowered to sell tangible items of personal property belonging to the Village that is no longer needed for any municipal purposes, in accordance with sections 721.01 – 721.26, inclusive, of the Revised Code; and

**Whereas**, section 721.15(D) of the Revised Code specifically empowers the Village to sell, regardless of the property's value, personal property, including, but not limited to, motor vehicles, road machinery, equipment, tools or supplies, which is not needed for public use or is obsolete or unfit for the use for which it was acquired, by internet auction upon adoption, during each calendar year, of a resolution expressing the Village's intent to sell such property by internet auction; and

**Whereas**, the Council of the Village of Elida, Ohio has in its possession personal property, including but not limited to, equipment, tools and supplies which are not needed for public use or are obsolete or unfit for the use for which they were acquired and the Council for the Village of Elida, Ohio has determined that the best method to dispose of said property is pursuant to internet auction per O.R.C. 721.15; and

**Whereas**, the Council desires to enter into a contract with GovDeals.com for conducting internet auction for the disposition of unneeded, obsolete or unfit personal property that includes the general terms and conditions of sale; and,

**Whereas**, the Council requires the contract specifically provide: (i) that the internet auction shall satisfy the statutory minimum of ten days (including Saturdays, Sundays and legal holidays) for bidding on the property, and (ii) that the Council reserves the right to set a minimum price to be accepted for specific items and any other terms and condition for a particular sale, such as requirements for pick-up or delivery, method of payment, and sales tax, if it so elects and notifies GovDeals.com of the same which shall be provided on the internet at the time of the auction, and, (iii) that no proceeds from the internet sales shall be paid in cash, rather all proceeds shall be delivered to the Fiscal Officer by cashier or bank certified check, or electronic transfer to the Village's general fund with verification of receipt delivered to the Fiscal Officer; and,

**Whereas**, notice of the Council's intent to sell unneeded, obsolete or unfit municipal personal property by internet auction, is to be published, twice, in a newspaper of general circulation in the Village, including a summary of the information contained within this Resolution, and the second publication shall be published not less than ten or more than twenty days after the initial publication; and

**Whereas**, upon the effective date of this Resolution, the Village shall cause notice of this Resolution and the website address for GovDeals.com to be posed continually throughout the calendar year in a conspicuous place in the office of the Village, as well as continuously throughout the calendar year on the Village's website.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ELIDA, OHIO, TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING:**

**Section 1.** Council of the Village of Elida, Ohio hereby resolves to sell personal property, including but not limited to equipment, tools and supplies which are not needed for public use or are obsolete or unfit for the use for which they were acquired by internet auction.


**Section 2.** Council further authorizes the Village of Elida, Ohio to enter into a memorandum of understanding/contract ("contract") with GovDeals, Inc., 5907 Carmichael Place, Montgomery, Alabama 36117, (866)-377-1494, that is in substantial conformity with the contract previously entered into with GovDeals, Inc. for calendar years 2021/2022/2023/2024/2025.

**Section 3.** That the Council adopts this resolution and that the recitals contained within the Whereas Clauses set forth above are incorporated herein by reference herein.

**Section 4.** That the Council of the Village of Elida, Ohio hereby finds that all discussion and debate regarding the matter was conducted in open session of council pursuant to the provisions of the Ohio Revised Code.

**Section 5.** That the Village Fiscal Officer shall and hereby is authorized and directed to cause publication of this Resolution to be made in a manner as provided for according to law.
