

ORDINANCE NO. 1250-2026

AN ORDINANCE: AUTHORIZING A WORKING AGREEMENT BETWEEN THE ALLEN SOIL AND WATER CONSERVATION DISTRICT (SWCD) AND THE VILLAGE OF ELIDA, OHIO AS SET FORTH IN THE MEMORANDUM OF UNDERSTANDING (ATTACHED HERETO AS EXHIBIT "A") AND DIRECTING THE MAYOR AND/OR ADMINISTRATOR OF THE VILLAGE OF ELIDA, OHIO, TO ENTER INTO SAID MEMORANDUM OF UNDERSTANDING.

Whereas, the Council of the Village of Elida, Ohio met at a duly called and authorized meeting of the Council, such meeting being duly called pursuant to the rules of Council, with notice received by all Council members; and

Whereas, the Village of Elida, Ohio is required to comply with a storm water management plan as dictated by the Ohio EPA and pursuant to Ohio Administrative code 3745-39-03(B)(1) through (6); and

Whereas, it is in the best interest of the citizens of the Village of Elida, Ohio to enter into a working agreement with the Allen SWCD to assist in coordinating activities and implementing said plan, addressing plan deficiencies, to assist in reporting to the Ohio EPA, to assist in acting as liaison between the Village and SWCD, and to assist in data compilation and recordkeeping; and

Whereas, the Village of Elida, Ohio shall compensate the SWCD in the form of an annual grant at the start of this working agreement in the amount of \$3,100.00, renewable and adjusted annually.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ELIDA, OHIO, TWO-THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING:

Section 1. That the Council of the Village of Elida, Ohio, hereby determines that it is in the best interest of the citizens of the Village of Elida, Ohio to enter into a working agreement with the SWCD to assist in coordinating activities and implementing said plan, addressing plan deficiencies, to assist in reporting to the Ohio EPA, to assist in acting as liaison between the Village and SWCD, and to assist in data compilation and recordkeeping, and joining Allen County as a co-permittee.


Section 2. That the Mayor and/or Village Administrator of the Village of Elida, Ohio, be and hereby is authorized and directed to accept and enter into the Memorandum of Understanding with the SWCD, a copy of said Memorandum of Understanding being attached hereto as Exhibit "A".

Section 3. That the Village Fiscal Officer of the Village of Elida, Ohio, is authorized and directed to pay the SWCD the amount of \$3,100.00 in the form of an annual grant, renewable and adjusted annually, as compensation to SWCD for its performance as outlined in the Memorandum of Understanding.

Section 4. The Village Fiscal Officer for the Village of Elida, Ohio is authorized and directed to cause publication of this Ordinance to be made in a manner as provided for according to law.


Section 5. That the Council of the Village of Elida, Ohio hereby finds that all discussion and debate regarding the matter was conducted in open session of council pursuant to the provisions of the Ohio Revised Code. This ordinance shall take effect and be in full force from and after its passage, provided that it receives the affirmative vote of two-thirds of the members elected to the Village Council; and approval by the Mayor.
